03.1 President's Report

The President's Report along with Program Council minutes were previously distributed (copy on file). Michel provided an overview of his report.

With regard to Surrey Police Services, Michel, Colleen and Mike have monthly updates with the Chief Constable, who is forecasting their first intake of Police recruits in January 2022.

Colleen continues to work with the Deans and Education Directors, to evaluate face to face or on-line classes from September through to December this year. While JIBC has always provided on-line classes, the virtual format provides wider access to students, and is proving to be very

effective. We anticipate providing more face to face classes in January 2022 but we are not expecting to return to pre-Covid days by incorporating more hybrid or flex models of delivery.

2021-01-04 GOVERNANCE MATTERS (BOARD OPERATIONS)

04.1 Policy: Financial Management with Procedures*

A revised draft Financial Management policy along with a procedure on signing levels and authorities was previously distributed (copy on file). Following brief discussion the motion was called.

04.2 Policy: International Education Activities*

The draft International Education Activities Policy was previously distributed (copy on file).

Much discussion took place and the following points were noted:

- * The policy is progressive and forward looking and reflects formalizing past guidelines.
- Specifically to Policing, JIBC is the only PSI that contains a Police Academy within a public post-secondary education institution;
- * management to review other guidelines from the Canadian Charter of Rights and Freedoms; be more specific in terms of what we are defining as problematic behaviour from another state before we engage with them;
- The policy is a high level summary and would benefit with a more explicit definition of human rights with more accuracy;
- * There are different degrees of violations and it will be helpful to understand the risk assessment as to how decision making for different types of potential training and education opportunities are determined, i.e. Policing, Emergency Management, Fire Fighting –
- * What is our obligation as an institution to try and better the norms in countries through our training and education programming activities? If a government with human rights violations changes to one that might be acceptable, would we look at training in a new light? Try to remain as flexible as possible.
- * Being able to review the accompanying procedures will assist in understanding how the policy will be operationalized.
- * This is an institutional policy procedures can be more delineated, especially about policing in particular.
- * Take into account the Federal and Provincial jurisdictions.

Governors concurred the policy will need more work and recommended to table this item until the June meeting.

THAT a procedure be provided as to how the policy will be operationalized. This item will be bought forward to the June 3rd 2021 meeting.
