- V2536 **Amy Yu Negotiation Assessment: Strong** (video, 120 minutes)
This assessment involves a negotiation between a representative of the staff in a social services agency and the executive director. These issues concern staffing, standards of service delivery, weekly committee participation and weekly reports. (Justice Institute of B.C. Centre for Conflict Resolution Training) (BF 637 N4 A488 1996)
- V2987 **Bev Alder: Negotiation Assessment** (video, 92 minutes)
This is a simulated negotiation between the owner of a cabinet-making shop and one of her employees. The employee is also using the shop for her private contract business. The topics under discussion include deadlines of orders, repairs to the machines, and the overall cost and access to equipment and the facilities. (Justice Institute of B.C. - V1714 **Linda Cross: Negotiation Assessment: Strong** (video, 74 minutes)
This is a simulated negotiation involving a landlord and tenant who are meeting to discuss a rent increase and other rental issues. (Justice Institute of B.C. Centre for Conflict Resolution Training) (BF 637 N4 L434 1994)

This shows a simulated negotiation in an informal setting concerning a renovation project which is incomplete. The negotiation is between the homeowner and the contractor. (Justice Institute of B.C. Centre for Conflict Resolution) (BF 637 N4 L435 1995)
