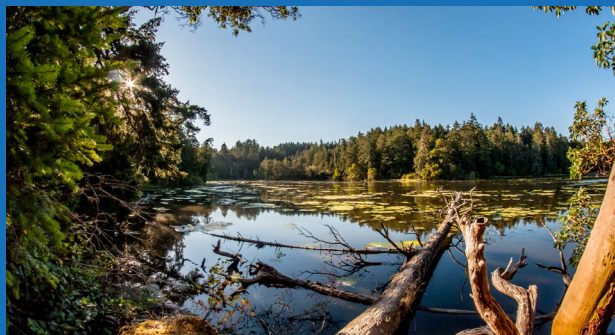


# Trauma-Informed Practice (TIP) Webinar Series

*Vicarious trauma (VT) is the emotional residue of exposure that those who assist trauma survivors, including front-line social workers, justice system professionals, and first responders, have from working with people as they are hearing their trauma stories and become witnesses to the pain, fear, and terror that trauma survivors have endured.*

#### **Nancy Poole**

Nancy is a national leader in creating and advocating change initiatives, training curricula and guidelines in trauma-informed practice. In her role as the Director of the Centre of Excellence for Women's Health, a virtual NGO research centre hosted by BC Women's Hospital & Health Care, she leads knowledge translation, network development, and research related to improving policy and service provision related to girls' and women's health, and introducing sex and gender in all health research. Nancy has co-led system change initiatives, and co-developed toolkits training curricula and guidelines on trauma-informed practice with agencies, institutes and governments across Canada.

#### **Sergeant Glenn Burchart, Vancouver Police Department (VPD)**

Glenn has been a member of the VPD since 1999. He began his policing career walking the beat in the Downtown Eastside for almost five years. He was a detective in the VPD Sex Crimes Unit for five years followed by four years as a Homicide investigator. Glenn became a certified Polygraph Examiner and led the VPD Polygraph Unit for the three years. Between 2015 and mid-2019 he was the sergeant in charge of the VPD Counter Exploitation and Internet Child Exploitation (ICE) Units. In mid-2019 Glenn became the sergeant in charge of the VPD Sex Crimes Unit-Team One where he leads police members who investigate child abuse cases at the Vancouver Child and Youth Advocacy Center.



#### **Meena Dhillon, Lawyer**

Meena is a lawyer with a background in social work. As a sole practitioner, her practice focuses on completing views of the child reports for family law matters, wills/estates, plaintiff's personal injury and conducting ICBC material damage arbitrations. As a social worker, Meena has worked in the area of child protection for 18 years. In addition, she is a sessional professor at the University of the Fraser Valley School of Social Work and Human Service where she teaches course work on child welfare intersections with the law and child welfare policy. Meena is passionate about access to justice and diversity, and as a result is a founding member of the South Asian Legal Clinic of British Columbia.



#### **Sally Tan, Correctional Service Canada**

Sally has spent most of the last 17 years in the correctional and criminal justice field. She spent her first five years as a correctional officer at Burnaby Correctional Centre for Women, and the next two years as a Mental Health Court Outreach Worker for the MPA Society with individuals in the Downtown Eastside with dual diagnosis who were struggling to navigate the criminal justice system. These two positions motivated Sally to pursue a career in psychology. She is a fully Registered Psychologist in Alberta and an Associate Psychologist (Corrections) in BC. For the past 11 years Sally has worked for Correctional Service Canada at the Fraser Valley Institution for Women and for Metro Vancouver West Community Corrections (formerly Vancouver Parole) providing psychological risk assessments and treatment/interventions to parolees for various mental health and risk related concerns.
