Options for Students Enrolled in a Discontinued Certificate:

1. Complete your certificate prior to Aug 31, 2023

Students who are currently enrolled in one of the certificates being discontinued have until August 31, 2023 to complete the certificate requirements.

Note some electives will be discontinued and other elective options will be added.

2. Transfer into the new certificate

Students who want to transfer into the <u>new Certificate in Collaborative Conflict Resolution</u> (<u>CCCR</u>), can contact the centre to make this request. Many courses for existing certificates are also accepted for the new certificate. To review what courses are accepted, see the section titled "Courses Accepted Between Certificates". Applications for the <u>new Certificate in</u> <u>Collaborative Conflict Resolution</u> accepted starting **July 1, 2021.** There is no fee to transfer to the new certificate program.

Options for Students not Enrolled in a Certificate Program:

1. Students who have completed most of the courses in one of the discontinued programs

Students who are <u>not</u> currently enrolled in a certificate program but have completed most of the courses have a choice between transferring to the new certificate or completing the certificate being discontinued. Students can apply for the certificate program being discontinued until **August 31, 2021**. They will have until **August 31, 2023** to complete the certificate requirements.

2. Students who have taken a limited number of courses in conflict resolution

We recommend that these students apply for the <u>new Certificate in Collaborative Conflict</u> <u>Resolution</u>. Applications accepted starting July **1**, **2021**. Students have four years from the date they are enrolled to complete the certificate.

Courses Accepted Between Certificates:

With a few exceptions, courses that students have already taken towards an existing certificate count towards the new Certificate in Collaborative Conflict Resolution (CCCR).

Courses listed in the table below are accepted in the new Certificate in Collaborative Conflict Resolution (CCCR). In some instances, only the course name has changed, and the course code remains the same.

Program Refresh FAQ

1. Q: What's the difference between the current certificates, Certificate in Conflict Resolution: Specialization in Mediation/Third Party Intervention, the Certificate in Conflict Resolution: Specialization in Negotiation, and the *new* Certificate in Collaborative Conflict Resolution (CCCR)?

A: They all provide graduates with a unique combination of theoretical knowledge and applied capabilities that prepares them to effectively participate in a collaborative, interest-based conflict engagement and resolution process. However, the new certificate is modernized and reflects current influences in theory and practice in the field of conflict resolution.

The new CCCR is a 20-credit program, and the current program consists of 18 credits.

Key themes in the *new* Certificate in Collaborative Conflict Resolution

- Use of JIBC's expertise in experiential teaching and learning methodology to balance theoretical concepts and their practical application to the processes of negotiation, mediation, and conflict coaching.
- Deeper learning and connection through the use of rich resources and tools, such as skills demonstration videos, enhanced coaching opportunities, and e-portfolios to document, reflect and assess learning progression.
- Engagement with, and consideration of the implications for the practice of key societal challenges such as Indigenization, gender equality, mental health, equity, diversity, and inclusion.
- Strengthening student access through multi-modal delivery options.

 Q: I am a certificate student who is halfway through the Conflict Resolution: Specialization in Mediation/Third-party Intervention or the Certificate in Conflict Resolution: Specialization in Negotiation, and I won't be able to complete the courses prior to August 31, 2023. What should I do?

A: If you can't complete your certificate prior to the deadline, you can contact the program area by email at <u>conres@jibc.ca</u> or by phone at **604.528.5825** and ask to be transferred into the *new* CCCR program. There will be no fee for this transfer. With some exceptions, most courses you have taken are accepted in the new program. If you have taken courses that are no longer applicable and want to receive credit for them, then you would need to complete the old certificate prior to **August 31, 2023.** To determine if any of the courses you have taken are no longer being offered please see the list of "Discontinued Courses."

3. Q: I have almost completed all the courses for the Conflict Resolution: Specialization in Mediation/Third-party Intervention or the Certificate in Conflict Resolution: Specialization in Negotiation, but I haven't enrolled in a certificate program. Should I apply for enrolment in the old certificate or in the new certificate?

A: This is your choice. All three are valued programs. If you can complete the old certificate by **August 31, 2023** and have already taken the elective courses that will no longer be applicable in the new certificate, you may want to focus on completing the Conflict Resolution: Specialization in Mediation/Third-party Intervention or the Certificate in Conflict Resolution: Specialization in Negotiation. If you choose to apply for the <u>new CCCR</u>, once accepted you will have four years to complete the certificate.

4. Q: Should I wait until Sept 2021 to take conflict resolution courses?

A: There is no reason to wait for the new courses since all required courses that you take will be accepted in the new certificate. In many cases, the content is similar but refreshed to include updated references and terminology. If you plan to apply for the <u>new CCCR program</u>, you will not want to take any discontinued elective courses as they will not be accepted into the new program.

5. Q: Is the new certificate better than the old certificate?

A: All certificates are valuable credentials. The new certificate features enhanced engagement with periodic coaching from program faculty, and a more integrative assessment methodology, including an e-portfolio.

6. Q: I haven't taken a course yet. Which program should I enrol in?

A: You can take a number of courses without enrolling in a program. If enrolment in a program is your goal we strongly recommend you apply for enrolment in the <u>new CCCR</u>. Applications are being accepted for the new program starting **July 1, 2021**.
