The Paramedic Academy at the Justice Institute of British Columbia invites applications from individuals interested in sessional employment as an Instructor for the Emergency Medical Responder (EMR) course at our **Chilliwack/Maple Ridge Campus.**

Are you in a clinical healthcare role, and you are considering moving your career toward education, or do you have experience teaching short courses and programs, and enjoy the fast-paced nature of short courses? Are you passionate about assisting learners as they explore a new career path? You might be exactly who we are looking for!

As the successful candidate, you will join an instructional team that includes fulltime EMR, Primary Care Paramedic (PCP), and Advanced Care Paramedic (ACP) Lead Instructors, as well as other sessional instructors teaching at all levels across the province. Sessional instructors have access to professional development through the JIBC Centre for Teaching and Learning Innovation, and funding (by application) for external courses and programs. In addition to teaching classes at our Chilliwack and Maple Ridge Campuses, there are occasional opportunities for travel and course delivery in rural and remote areas of the province for instructors who indicate interest in those assignments.

We intend to fill *one position* from this posting through a selection process that will include submission of a resume and an interview process. Sessional employees will be used on an "on-call, as needed" basis.

Primary Responsibilities:

- Teach all or portions of the EMR course; (You can see an overview of the EMR course here)
- Perform student evaluations;
- Provide written and verbal feedback to the students;
- Document student progress for student records;
- Convey training concerns from students to the EMR Lead Instructor and/or Program Manager;
- Assist students with tutorials and remediation, when required.

Qualifications:

- Licensed through the Emergency Medical Assistants Licensing Branch of British Columbia at the PCP level or higher:
- Canadian Red Cross Professional Responder Instructor Certificate- preferred;
- Completed the Essential Skills for Training and Facilitation (INDC-1110) course, Instructional Skills Workshop, or equivalent preferred;
- Completion of diploma or higher academic education credential in paramedicine or other area related to health science (kinesiology, nursing, etc.) preferred;
- 5-7 years or more experience working in a field related to health science preferred;
- Demonstrated computer skills word processing, email and Internet navigation preferred;
- Excellent interpersonal skills;
- Two years' experience as a field practitioner (e.g. OFA, EMR, PCP or ACP);
- Excellent written and oral communication skills;
- Ability to work cooperatively with diverse training and development teams.
