All successful candidates must reside in the Lower Mainland to be able to work at the MRC as well as be available and accept up to four instructor assignments per month.

Emergency Vehicle Operations (NFPA 1002)
Firefighter Technology Certificate (NFPA 1001)

### **Required Qualifications:**

Candidates applying for these positions will have an established reputation and proven record in the emergency service industry, including the skills and abilities necessary to instruct the curriculum. Candidates are required to have recognized training and educational credentials equivalent to one level above the content area. A suitable combination of education and experience may be considered. Candidates must also meet the following requirements:

- NFPA 1001 Firefighter Level II- JIBC certified (or an equivalent combination of training and experience);
- NFPA 1021 Fire Officer I JIBC certified (or an equivalent combination of training and experience);
- Fire Service Instructor level II (or an equivalent combination of training and experience);
- Completion of the JIBC Evaluator Course (FIRE 1052);
- Teaching experience preferred;
- High level of proficiency with using computer software as support tools in delivering instruction, such as Outlook, Excel, Word, and PowerPoint, and the internet;
- Willingness to assume leadership roles;
- Ability to work within a dynamic team in an exciting environment;
- Commitment to a collaborative and innovative approach to education;
- Flexible availability and willingness to travel throughout the province;
- Excellent written and oral communication, interpersonal skills, and a desire to share knowledge with others.
