During and after disasters, vital resources invariably become scarce. To retain order and maintain the public's confidence, leaders must make allocation decisions ethically, providing resources to those most in need. In these situations, decision makers must decide how to prioritize between the needs of different patients and communities. The program addresses difficult allocation decisions in all types of disasters: at on-scene (multi-casualty incident), institutional, local, regional, and statewide levels.
